PROCLAMATION - FARM-CITY WEEK

Chairman Tuck read the Proclamation for Farm-City Week proclaiming November 18-24, 2016 as Farm-City Week in Georgia. The proclamation calls upon citizens in rural and urban areas to acknowledge and celebrate the achievement of all those who, working together, produce and supply our community and nation with an abundance of agricultural products.

MANAGERS REPORT

- Tractor Supply will appear before the Planning Commission on November 28th to request the designation of PD-2 Commercial Development and formal announcement.
- The date for the 2016 Christmas Parade has been set for Thursday, December 1st with the Christmas Tree lighting ceremony that same week on Tuesday, November 29th. Both events will begin at 6 p.m.
- We have received an "A" rating from S&P Global for the bond refunding issue. S&P cited a "strong enterprise risk profile and strong financial risk profile" in their report indicating among other things "very low industry risk, good operational management practices and a very strong liquidity position".
- Project updates Verizon Tower, Inman Solar Phase II, Vantage Development, Big Spring.
- Projects out for bid CDBG Sewer project and Lankford Event Center.
- Old landfill site fourth five-year review completed by EPA and EPD.
- We have completed insurance negotiations for our 2017 coverages and unfortunately will endure a ten percent increase in healthcare premiums after receiving an original proposal of 31%. According to the Associated Press the average increase trends between 8% and 14% nationally and there are large variations from state to state and even within states. On a better note we are expecting about an 8% decrease in workers compensation insurance due to very good claims experience over the last three years. In that period we have averaged just 7.5 claims per year where in the previous ten years we averaged over 16 claims per year. Most of this reduction is due to better management and safety training throughout the departments.
